-Toyota Boshoku Acquires Capital in Tokai Chemical -

Kariya (Japan) 29<sup>th</sup> August 2012 – Toyota Boshoku Corporation (head office Kariya, Japan, President Shuhei Toyoda) and Tokai Rubber Industries, Ltd. (head office Komaki, Japan, President Yoshiaki Nishimura, hereafter "Tokai Rubber") announced today that they are strengthening their cooperative relationship in the development of automobile interior components.
